UNANIMOUS CONSENT AGREEMENTS

S. 1926 (ORDER NO. 294)

1.—*Ordered*, That upon the conclusion of Morning Business on Wednesday, January 29, 2014, the Senate resume consideration of the motion to proceed to S. 1926, a bill to delay the implementation of certain provisions of the Biggert-Waters Flood Insurance Reform Act of 2012 and to reform the National Association of Registered Agents and Brokers, and for other purposes; provided, that all post-cloture time be yielded back and the motion to proceed be agreed to.

Ordered further, That after the bill is reported, the following amendments be agreed to:

Hagan #2702;
 Rubio #2704;
 King #2705; and
 Blunt #2698; provided, that the amended text be considered as original text for the purposes of further amendment; that the only other amendments in order be the following:

Reed (RI) #2703 (community based policy study);
 Coburn #2697 (NARAB alternative);
 Merkley #2709 (forced placed insurance);
 Heller #2700 (state authority—private flood insurance);
 Whitehouse #2706 (fee waiver);
 Toomey #2707 (substitute); and
 Gillibrand #2708 (mitigation guidelines).

Ordered further, That no second degree amendments be in order to any of these amendments prior to votes in relation to the amendments; that it be in order for the Senator from Pennsylvania (Mr. Toomey) to modify his amendment with the text of the Rubio amendment #2704 and the Hagan amendment #2702.

Ordered further, That there be 30 minutes of debate equally divided on each amendment or motion to waive a budget point or order, if made and that there be up to one hour of general debate on the bill equally divided between proponents and opponents; provided, that amendments in this agreement must be offered prior to 3 p.m. on Wednesday, January 29th; provided further, that it be in order for the Senator from Idaho (Mr. Crapo), or his designee, to raise a budget point of order against the bill and that if such a point of order is raised, the Senator from New Jersey (Mr. Menendez), or his designee, be recognized to move to waive the point of order.

Ordered further, That upon the use or yielding back of time, the Senate proceed to the vote on the motion to waive, if made; that if the motion to waive is agreed to, the Senate proceed to votes in relation to the amendments in the order listed; that upon disposition of the amendments, the bill be read a third time and the Senate proceed to vote on passage of the bill, as amended, if amended. (*Jan. 28, 2014.*)

S. 1302 (ORDER NO. 230)

2.—*Ordered*, That if the Senate receives from the House of Representatives a bill that is identical to the text of S. 1302, an act to amend the Employee Retirement Income Security Act of 1974 and the Internal Revenue Code of 1986 to provide for cooperative and small employer charity pension plans, as passed by the Senate, the House bill be read three times and passed with no intervening action or debate. (*Jan. 28, 2014.*)

S. 1845 (ORDER NO. 265)

3.—*Ordered*, That the filing deadline for first degree amendments to S. 1845, a bill to provide for the extension of certain unemployment benefits, and for other purposes, be 3:00 p.m. on Monday, January 13, 2014, and the filing deadline for second degree amendments to S. 1845 be 11:00 a.m. on Tuesday, January 14, 2014.

Ordered further, That with respect to the motion to invoke cloture on S. 1845, the mandatory quorum required under Rule XXII be waived. (*Jan. 9, 13, 2014.*)

S. 1197 (ORDER NO. 91)

4.—*Ordered*, That with respect to the cloture motion on S. 1197, an original bill to authorize appropriations for fiscal year 2014 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the mandatory quorum required under Rule XXII be waived.

Ordered further, That the filing deadline for first degree amendments be 1:00 p.m. and that the filing deadline for second degree amendments be 5:00 p.m. on Thursday, November 21, 2013. (*Nov. 20, 2013.*)

S. CON. RES. 8

5.—*Ordered*, That with respect to the conference on S. Con. Res. 8 an original concurrent resolution setting forth the congressional budget for the United States Government for fiscal year 2014, revising the appropriate budgetary levels for fiscal year 2013, and setting forth the appropriate budgetary levels for fiscal years 2015 through 2023, the conferees on the part of the Senate are instructed to report back a conference report by December 13, 2013.

Ordered further, That it not be in order for the Senate to consider a conference report with respect to H. Con. Res. 25 or S. Con. Res. 8 if it includes reconciliation instructions to raise the debt limit. (*Oct. 16, 2013.*)

S. 1569 (ORDER NO. 211)

6.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 1569, a bill to ensure the complete and timely payment of the obligations of the United States Government until December 31, 2014, the mandatory quorum required under Rule XXII be waived. (*Oct. 10, 2013.*)

S. 1392 (ORDER NO. 154)

7.—*Ordered*, That with respect to S. 1392, a bill to promote energy savings in residential buildings and industry, and for other purposes; no amendments or motions be in order relative to Syria or the use of military force during consideration of the bill. (*Sept. 11, 2013.*)

S. 1243 (ORDER NO. 99)

8.—*Ordered*, That the text of H.R. 2610, as reported by the House Appropriations Committee, be deemed House-passed text for the purposes of Rule XVI for S. 1243, an original bill making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2014, and for other purposes.

Ordered further, That the filing deadline for first degree amendments be 1:30 p.m. on Wednesday, July 31, 2013 and the filing deadline for second degree amendments be 11:00 a.m. on Thursday, August 1, 2013.

Ordered further, That with respect to the cloture motion filed on S. 1243, the mandatory quorum required under Rule XXII be waived. (*July 18, 31, 2013.*)

S. 1238 (ORDER NO. 124)

9.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1238, a bill to amend the Higher Education Act of 1965 to extend the current reduced interest rate for undergraduate Federal Direct Stafford Loans for 1 year, to modify required distribution rules for pension plans, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*July 8, 2013.*)
