UNANIMOUS CONSENT AGREEMENTS

S. 178 (ORDER NO. 26)

1.—*Ordered*, That following Leader Remarks on Wednesday, April 22, 2015, the Senate resume consideration of S. 178, a bill to provide justice for the victims of trafficking; provided, that the Senator from Texas (Mr. Cornyn) or his designee be recognized to withdraw Amdt. No. 1120 and offer Amdt. No. 1124 (for himself, Mrs. Murray and Ms. Klobuchar) and Amdt. No. 301, proposed by the Senator from Vermont (Mr. Leahy); provided further, that there be 1 hour of debate, equally divided in the usual form, and that following the use or yielding back of time, the Senate vote on Amdt. No. 301, followed by a vote on Amdt. No. 1124; further, that each amendment be subject to a 60 vote affirmative threshold for adoption.

Ordered further, That if Amdt. No. 1124 is agreed to, the time until 2:00 p.m. be equally divided in the usual form and the Senate then vote on the following amendments in the order listed:

- Cornyn Amdt. No. 1127;
- Leahy Amdt. No. 290;
- Brown Amdt. No. 311;
- Burr Amdt. No. 1121;
- Kirk Amdt. No. 273.

Ordered further, That amendments listed above be subject to a 60 vote affirmative threshold for adoption; provided, that there be 2 minutes of debate equally divided between each vote.

Ordered further, That following disposition of these amendments, there be 5 minutes equally divided in the usual form followed by votes on the following amendments:

- Klobuchar Amdt. No. 296;
- Hoeven Amdt. No. 299, as modified;
- Sullivan Amdt. No. 279;
- Wicker Amdt. No. 1126;
- Flake Amdt. No. 294;
- Cassidy Amdt. No. 308;
- Portman Amdt. No. 1128;
- Brown Amdt. No. 310;
- Brown Amdt. No. 312;
- Heller Amdt. No. 1122;
- Shaheen Amdt. No. 303.

Ordered further, That no second degree amendments be in order to any of the amendments listed above; provided, that upon disposition of Amdt. No. 303, the committee-reported substitute as amended be agreed to, the bill as amended be read a third time and the Senate vote on passage.

Ordered further, That with respect to the motion to invoke cloture filed on S. 178, on March 12, 2015, the filing deadline for first degree amendments be 5:00 p.m. on Monday, March 16, 2015 and the filing deadline for second degree amendments be 10:30 a.m. on Tuesday, March 17, 2015; provided, that with respect to the motions to invoke cloture on S. 178 and the motion to invoke cloture on the committee reported substitute to S. 178, the mandatory quorum required under Rule XXII be waived. (*Mar. 12, 16, 17, 18; Apr. 21, 2015.*)

H.R. 1191 (ORDER NO. 30)

2.—*Ordered*, That at a time to be determined by the Majority Leader with the concurrence of the Democratic Leader, the Senate vote on the motion to proceed to H.R. 1191, an Act to amend the Internal Revenue Code of 1986 to ensure that emergency services volunteers are not taken into account as employees under the shared responsibility requirements contained in the Patient Protection and Affordable Care Act; provided, that if the motion to proceed is agreed to, the Senator from Tennessee (Mr. Corker), or his designee, be recognized to offer a substitute amendment that is the text of S. 615, as reported by the Committee on Foreign Relations. (*Apr. 16, 2015.*)

VETO MESSAGE ON S.J. RES. 8

3.—*Ordered*, That if the Senate receives a veto message to accompany S.J. Res. 8, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the National Labor Relations Board relating to representation case procedures, the veto message be considered as having been read, printed in the Record, spread in full upon the Journal, and held at the desk; provided, that the Senate proceed to the consideration of the veto message at a time to be determined by the Majority Leader, with concurrence of the Democratic Leader, but no later than April 30, 2015. (*Mar. 27, 2015.*)

S. 534 (ORDER NO. 22)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
