**UNANIMOUS CONSENT AGREEMENTS**

## S. CON. RES. 16 (ORDER NO. 72)

1.—*Ordered*, That at 5:00 p.m. on Monday, May 11, 2015, the Senate proceed to the consideration of S. Con. Res. 16, stating the policy of the United States regarding the release of United States citizens in Iran; provided, that there be 30 minutes of debate, equally divided in the usual form, and that the Senate then vote on adoption of the concurrent resolution with no intervening action or debate. (*May 7, 2015.*)

## H.R. 1314 (ORDER NO. 58)

2.—*Ordered*, That, notwithstanding the provisions of Rule XXII of the Standing Rules of the Senate, at 2:30 p.m. on Tuesday, May 12, 2015, the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 1314, an Act to amend the Internal Revenue Code of 1986 to provide for a right to an administrative appeal relating to adverse determinations of tax-exempt status of certain organizations. (*May 7, 2015.*)

## S. 534 (ORDER NO. 22)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
