UNANIMOUS CONSENT AGREEMENTS

H.R. 1314 (ORDER NO. 58)

1.—*Ordered*, That, upon the conclusion of Morning Business on Wednesday, May 13, 2015, the Senate resume consideration of the motion to proceed to H.R. 1314, an Act to amend the Internal Revenue Code of 1986 to provide for a right to an administrative appeal relating to adverse determinations of tax-exempt status of certain organizations; provided, that the mandatory quorum call under Rule XXII be waived. (*May 11, 12, 2015.*)

S. 534 (ORDER NO. 22)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)

When objection is heard to immediate consideration of a resolution or motion when submitted, it shall be placed here, to be laid before the Senate on the next legislative day for consideration, unless by unanimous consent the Senate shall otherwise direct. (Rule XIV, Paragraph 6.)
