**UNANIMOUS CONSENT AGREEMENTS**

H.R. 1295 (ORDER NO. 57) AND H.R. 644 (ORDER NO. 56)

1.—*Ordered*, That on Thursday, May 14, 2015 at 10:00 a.m., the Senate proceed to the en bloc consideration of H.R. 1295, an Act to amend the Internal Revenue Code of 1986 to improve the process for making determinations with respect to whether organizations are exempt from taxation under section 501(c)(4) of such Code, and H.R. 644, an Act to amend the Internal Revenue Code of 1986 to permanently extend and expand the charitable deduction for contributions of food inventory; provided, that the amendments offered by the Senator from Utah (Mr. Hatch) to H.R. 1295 and H.R. 644, the texts of which are S. 1267 and S. 1269, be considered and agreed to; provided further, that no further amendments be in order; further, that at 12:00 noon, the bills, as amended, each be read a third time and the Senate vote on passage of H.R. 1295, as amended, followed by a vote on passage of H.R. 644, as amended, with no intervening action or debate; further, that there be a 60 affirmative vote threshold for passage of each bill and that if passed, the motions to reconsider be considered made and laid upon the table. (*May 13, 2015.*)

H.R. 1314 (ORDER NO. 58)

2.—*Ordered*, That on Thursday, May 14, 2015, upon disposition of H.R. 644, the motion to proceed to the motion to reconsider the failed cloture vote on the motion to proceed to H.R. 1314, an Act to amend the Internal Revenue Code of 1986 to provide for a right to an administrative appeal relating to adverse determinations of tax-exempt status of certain organizations, and the motion to reconsider the failed cloture vote on the motion to proceed to H.R. 1314 be agreed to; provided, that at 2:00 p.m., the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 1314, upon reconsideration; provided further, that if cloture is invoked, the 30 hours of post-cloture consideration under Rule XXII expire at 10:00 p.m. on May 14, 2015; further, that the mandatory quorum call under Rule XXII be waived. (*May 11, 13, 2015.*)

S. 534 (ORDER NO. 22)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
