**UNANIMOUS CONSENT AGREEMENTS**

## H.R. 22 (ORDER NO. 19)

1.—*Ordered*, That on Tuesday, July 21, 2015 at 2:15 p.m., the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 22, an Act to amend the Internal Revenue Code of 1986 to exempt employees with health coverage under TRICARE or the Veterans Administration from being taken into account for purposes of determining the employers to which the employer mandate applies under the Patient Protection and Affordable Care Act. (*July 16, 2015.*)

## H.R. 2685 (ORDER NO. 118)

2.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*June 18, 2015.*)

## S. 1357 (ORDER NO. 86)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

## S. 534 (ORDER NO. 22)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
