## UNANIMOUS CONSENT AGREEMENTS

### S. 754 (ORDER NO. 28)

1.—*Ordered*, That, following Leader Remarks on Tuesday, October 27, 2015, the Senate resume consideration of S. 754, a bill to improve cybersecurity in the United States through enhanced sharing of information about cybersecurity threats, and for other purposes; provided, that the time until 11:00 a.m. be equally divided between the two Leaders, or their designees; provided further, that at 11:00 a.m., notwithstanding Rule XXII, all post-cloture time be considered expired on Amdt. No. 2716, and the Senate vote in relation to the following amendments in the order listed:

- Wyden Amdt. No. 2621 as modified;
- Heller Amdt. No. 2548 as modified;
- Leahy Amdt. No. 2587 as modified;
- Flake Amdt. No. 2582; and
- Franken Amdt. No. 2612 as further modified.

*Ordered further*, That the time from 2:15 p.m. until 4:00 p.m. be equally divided in the usual form; provided, that at 4:00 p.m., the Senate vote in relation to the following amendments in the order listed:

- Coons Amdt. No. 2552 as modified;
- Cotton Amdt. No. 2581 as modified; and
- Burr/Feinstein substitute Amdt. 2716 as amended, if amended.

*Ordered further*, That, notwithstanding Rule XXII, there be two minutes of debate equally divided prior to each vote, and that all votes after the first vote in each series be 10 minutes each; provided, that if cloture is invoked on S. 754, all post-cloture time be yielded back, the bill, as amended, if amended, be read a third time, and the Senate vote on passage of S. 754, as amended, if amended, without any intervening action or debate.

*Ordered further*, That the filing deadline for all amendments in the second degree to both Amdt. No. 2716 and S. 754 be 10:30 a.m. on Thursday, October 22, 2015; provided, that with respect to the motion to invoke cloture on S. 754, the mandatory quorum under Rule XXII be waived. (*Aug. 5, Oct. 21, 22, 26, 2015.*)

### H.R. 2029 (ORDER NO. 98)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 2029, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Sept. 30, 2015.*)

### S. 1881 (ORDER NO. 169)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

### S. 1357 (ORDER NO. 86)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

### S. 534 (ORDER NO. 22)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
