UNANIMOUS CONSENT AGREEMENTS

H.R. 3762 (ORDER NO. 299)

1.—*Ordered*, That following Leader Remarks on Thursday, December 3, 2015, the Senate resume consideration of H.R. 3762, an Act to provide for reconciliation pursuant to section 2002 of the concurrent resolution on the budget for fiscal year 2016; provided, that the time until 1:30 p.m. be equally divided in the usual form; provided further, that all debate time be expired at 1:30 p.m.; further, that all time spent in quorum calls during the consideration of H.R. 3762 be equally divided and be charged to the debate time provided for the bill under the Congressional Budget Act of 1974. (*Dec. 2, 2015.*)

H.R. 2685 (ORDER NO. 118)

2.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Nov. 3, 2015.*)

S. 1881 (ORDER NO. 169)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

S. 1357 (ORDER NO. 86)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

S. 534 (ORDER NO. 22)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)

When objection is heard to the second reading of a bill or joint resolution, that measure is then laid before the Senate during morning business of the next legislative day for the second reading. (Rule XIV, Paragraph 2.)
