UNANIMOUS CONSENT AGREEMENTS

H.R. 636 (ORDER NO. 55)

1.—*Ordered*, That following Leader Remarks on Monday, April 18, 2016, the Senate resume consideration of H.R. 636, an Act to amend the Internal Revenue Code of 1986 to permanently extend increased expensing limitations, and for other purposes; provided, that, at 5:30 p.m., notwithstanding Rule XXII, Amdt. No. 3680, offered by the Senator from South Dakota (Mr. Thune), be agreed to, the substitute Amdt. No. 3679, offered by the Senator from Kentucky (Mr. McConnell), as amended, be agreed to, and the Senate vote on the motion to invoke cloture on H.R. 636.

Ordered further, That amendments submitted to the previous substitute, Amdt. No. 3464, offered by the Senator from South Dakota (Mr. Thune), be considered to be submitted to the new substitute Amdt. No. 3679 as long as the instructions to the Clerk are drafted properly; provided, that with respect to the motion to invoke cloture on H.R. 636, the mandatory quorum required under Rule XXII be waived. (*Apr. 12, 13, 14, 2016.*)

H.R. 2028 (ORDER NO. 96)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 2028, an Act making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2016, and for other purposes, Friday, April 15, 2016 count as the intervening day and the mandatory quorum under Rule XXII be waived. Ordered further, That following disposition of Paul Amdt. No. 3787, the Senate vote on Amdt. No. 2954, offered by the Senator from Louisiana (Mr. Cassidy), with a 60 vote affirmative threshold for adoption; provided, that following the disposition of Amdt. No. 2954, the substitute Amdt. No. 2953, offered by the Senator from Alaska (Ms. Murkowski), as amended, be agreed to and that notwithstanding Rule XXII, the Senate vote on the motion to invoke cloture, upon reconsideration, on S. 2012, as amended; provided further, that if cloture is invoked, all post-cloture time be yielded back, the bill be read a third time and the Senate vote on passage of S. 2012, as amended; further, the budget points of order not be barred by virtue of this agreement.

Ordered further, That with respect to the motions to invoke cloture on Amdt. No. 2953 and S. 2012, the mandatory quorum under Rule XXII be waived; provided, that the filing deadline for all first degree amendments to Amdt. No. 2953 and S. 2012 be at 1:00 p.m. on Wednesday, February 3, 2016. (*Feb. 2, Apr. 13, 2016.*)

HOUSE MESSAGE TO ACCOMPANY S. 764

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (*Mar. 14, 2016.*)

H.R. 2685 (ORDER NO. 118)

5.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Nov. 3, 2015.*)

S. 1881 (ORDER NO. 169)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

S. 534 (ORDER NO. 22)

8.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
