## UNANIMOUS CONSENT AGREEMENTS

### H.R. 2028 (ORDER NO. 96)

1.—*Ordered*, That following Leader Remarks on Tuesday, April 26, 2016, the Senate resume consideration of H.R. 2028, an Act making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2016, and for other purposes; provided, that the time until 11:00 a.m. be equally divided between the two managers or their designees; provided further, that it be in order to offer the following amendments:

- Merkley Amdt. No. 3812;
- Reid Amdt. No. 3805; and
- Flake Amdt. No. 3820;

further, that at 11:00 a.m. on Tuesday, April 26, 2016, the Senate vote on the amendments above in the order listed; provided further, that no second degree amendments be in order prior to the votes and that there be two minutes equally divided prior to each vote.

*Ordered further*, That Amdt. No. 3801, offered by the Senator from Tennessee (Mr. Alexander), as amended, be considered a committee-reported substitute; provided, that with respect to the motions to invoke cloture on Amdt. No. 3801, as amended, and H.R. 2028, the mandatory quorums required under Rule XXII be waived; provided further, that the filing deadline for all first degree amendments to both Amdt. No. 3801, as amended, and H.R. 2028 be at 2:30 p.m. on Tuesday, April 26, 2016. (*Apr. 20, 21, 25, 2016.*)

### HOUSE MESSAGE TO ACCOMPANY S. 764

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (*Mar. 14, 2016.*)

### H.R. 2685 (ORDER NO. 118)

3.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Nov. 3, 2015.*)

### S. 1881 (ORDER NO. 169)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

### S. 1357 (ORDER NO. 86)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

### S. 534 (ORDER NO. 22)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
