UNANIMOUS CONSENT AGREEMENTS

H.J. RES. 88 (ORDER NO. 460)

1.—Ordered, That following Leader Remarks on Tuesday, May 24, 2016, the Senate vote on adoption of the motion to proceed to H.J. Res. 88, joint resolution disapproving the rule submitted by the Department of Labor relating to the definition of the term "Fiduciary". (May 23, 2016).

S. 2943 (ORDER NO. 469)

2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 2943, a bill to authorize appropriations for fiscal year 2017 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the mandatory quorum required under Rule XXII be waived. (May 23, 2016).

HOUSE MESSAGE TO ACCOMPANY S. 764

3.—Ordered, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (Mar. 14, 2016.)

(May 23, 2015.)

S. 534 (ORDER NO. 22)

7.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
