No. 4749, offered by Mr. McConnell for the Senator from Texas (Mr. Cornyn), and the motion to invoke cloture on Amdt. No. 4720, offered by Mr. McConnell for the Senator from California (Mrs. Feinstein), the mandatory quorums under Rule XXII be waived. (June 17, 2016.)

(May 23, 2015.)

S. 534 (ORDER NO. 22)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
