UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE TO ACCOMPANY S. 764

1.—Ordered, That following Leader Remarks on Thursday, July 7, 2016, the Senate resume consideration of the House Message to Accompany S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes; provided, that all time during Morning Business, recess or adjournment of the Senate count post-cloture on the motion to concur in the House Amendment to S. 764 with Amdt. H.R. 5293 (ORDER NO. 524)

2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 5293, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2017, and for other purposes, the cloture motion ripen on Wednesday, July 6, 2016, upon the disposition of the Martinotti nomination and the mandatory quorum required under Rule XXII be waived. 6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

S. 534 (ORDER NO. 22)

7.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
