## S. CON. RES. 3 (ORDER NO. 1)

1.—*Ordered*, That, on Tuesday, January 10, 2017, following Leader remarks, the Senate resume consideration of S. Con. Res. 3, a concurrent resolution setting forth the congressional budget for the United States Government for fiscal year 2017 and setting forth the appropriate budgetary levels for fiscal years 2018 through 2026; provided, that it be in order to call up Amdt. No. 52, submitted by the Senator from Arizona (Mr. Flake), and that at 2:30 p.m. on Tuesday, the Senate vote in relation to Amdt. No. 52; provided further, that upon disposition of Amdt. No. 52, there be 2 minutes of debate, equally divided in the usual form, in relation to Amdt. No. 19, offered by the Senator from Vermont (Mr. Sanders) and that upon the use or yielding back of time, the Senate vote in relation to Amdt. No. 19. (*Jan. 5, 9, 2017.*)
