UNANIMOUS CONSENT AGREEMENT

S. 722 (ORDER NO. 110)

1.—*Ordered*, That on Wednesday, June 7, 2017, following Leader remarks, the Senate resume consideration of the motion to proceed to S. 722, a bill to impose sanctions with respect to Iran in relation to Iran's ballistic missile program, support for acts of international terrorism, and violations of human rights, and for other purposes; provided, that with respect to the motion to invoke cloture on the motion to proceed to S. 722, the mandatory quorum under Rule XXII be waived. (*June 5, 6, 2017.*)
