UNANIMOUS CONSENT AGREEMENT

S. 722 (ORDER NO. 110)

1.—*Ordered*, That on Thursday, June 8, 2017, following Leader remarks, the Senate resume consideration of the motion to proceed to S. 722, a bill to impose sanctions with respect to Iran in relation to Iran's ballistic missile program, support for acts of international terrorism, and violations of human rights, and for other purposes; provided, that the post-cloture time on S. 722 count as if cloture was invoked at 10:30 a.m., Wednesday, June 7; provided further, that all time during recess, adjournment, Morning Business, and Leader remarks count post-cloture on the motion to proceed to S. 722.
