**UNANIMOUS CONSENT AGREEMENTS**

## S.J. RES. 42

1.—*Ordered*, That on Tuesday, June 13, 2017, following Leader remarks, the Senator from Kentucky (Mr. Paul) or his designee, be recognized to offer a motion to discharge S.J. Res. 42, a joint resolution relating to the disapproval of the proposed export to the Government of the Kingdom of Saudi Arabia of certain defense articles; provided, that debate on the motion be equally divided between the proponents and opponents of the motion until 12:30 p.m.; provided further, that at 2:15 p.m. there be 10 minutes of debate remaining on the motion to discharge the resolution equally divided between the Senator from Kentucky (Mr. Paul) or his designee, and the opponents; further, that following the use or yielding back of that time, the Senate vote in relation to the motion to discharge. (*June 12, 2017.*)

## S. 722 (ORDER NO. 110)

2.—*Ordered*, That with respect to the cloture motion filed on Amdt. No. 232, offered by Mr. McConnell to S. 722, a bill to impose sanctions with respect to Iran in relation to Iran's ballistic missile program, support for acts of international terrorism, and violations of human rights, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*June 12, 2017.*)

When objection is heard to the second reading of a bill or joint resolution, that measure is then laid before the Senate during morning business of the next legislative day for the second reading. (Rule XIV, Paragraph 2.)
