UNANIMOUS CONSENT AGREEMENT

H.R. 1628 (ORDER NO. 120)

1.—*Ordered*, That, following Leader remarks, on Wednesday, July 26, 2017, the Senate resume consideration of H.R. 1628, an Act to provide for reconciliation pursuant to title II of the concurrent resolution on the budget for fiscal year 2017; provided, that the time until 11:30 a.m. be equally divided between the two Leaders or their designees; provided further, that at 11:30 a.m. the Senator from Washington (Mrs. Murray) or her designee be recognized to make points of order and that the Senator from Wyoming (Mr. Enzi) or his designee be recognized to make a motion to waive.

Ordered further, That, following the motion to waive, the Senate vote in relation to Amdt. No. 271 offered by the Senator from Wyoming (Mr. Enzi); and following the disposition of that amendment, the time until 3:30 p.m. be equally divided on the motion to commit offered by the Senator from Indiana (Mr. Donnelly), with a vote on the motion at 3:30 p.m.

Ordered further, That, following the disposition of the Donnelly motion to commit, Mrs. Murray or her designee be recognized to offer an additional motion to commit. (*July 25, 2017.*)
