UNANIMOUS CONSENT AGREEMENTS

H.R. 2 (ORDER NO. 483)

1.—*Ordered*, That on Thursday, June 28, 2018, following Leader remarks, the Senate resume consideration of H.R. 2, an Act to provide for the reform and continuation of agricultural and other programs of the Department of Agriculture through fiscal year 2023, and for other purposes; provided, that with respect to the motions to invoke cloture on Amdt. No. 3224, offered by the Senator from Kansas (Mr. Roberts) and H.R. 2, the mandatory quorums under Rule XXII be waived. (*June 27, 2018.*)

HOUSE MESSAGE TO ACCOMPANY S. 140

2.—*Ordered*, That with respect to the cloture motion filed on the motion to concur with a further amendment in the House Amendment to S. 140, an Act to amend the White Mountain Apache Tribe Water Rights Quantification Act of 2010 to clarify the use of amounts in the WMAT Settlement Fund, the mandatory quorum call under Rule XXII be waived.
