**UNANIMOUS CONSENT AGREEMENTS**

H.R. 5895 (ORDER NO. 449)

1.—*Ordered*, That, notwithstanding Rule XXII, at 12:00 noon on Wednesday, July 11, 2018, the Senate resume Legislative Session, and the Chair lay before the Senate the message to accompany H.R. 5895, an Act making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2019, and for other purposes; provided, that, the Majority Leader (Mr. McConnell), or his designee, be recognized to make a compound motion to go to conference, and the Senate vote on the motion; provided further, that if the motion is agreed to, the Senator from Louisiana (Mr. Cassidy) and the Senator from Tennessee (Mr. Corker) each be recognized to make a motion to instruct the conferees; further, that the Senate vote on the motions in order listed with no further action on the compound motion; provided further, that there be two minutes of debate between each vote, equally divided in the usual form; further, that following disposition of the Corker motion and the appointment of conferees, the Senate resume Executive Session. (*July 10, 2018.*)

## HOUSE MESSAGE TO ACCOMPANY S. 140

2.—*Ordered*, That with respect to the cloture motion filed on the motion to concur with a further amendment in the House Amendment to S. 140, an Act to amend the White Mountain Apache Tribe Water Rights Quantification Act of 2010 to clarify the use of amounts in the WMAT Settlement Fund, the mandatory quorum call under Rule XXII be waived. (*Apr. 16, 2018.*)
