No. 3399, offered by the Senator from Alabama (Mr. Shelby), Division B of H.R. 6147 serve as the basis for defense of germaneness for Division B of Amdt. No. 3399, that H.R. 5961, as reported by the House appropriations committee serve as the basis for defense of germaneness for Division C of Amdt. No. 3399, and that H.R. 6072, as reported by the House appropriations committee, serve as the basis for defense of germaneness for Division D of Amdt. No. 3399. (*July 23, 25, 2018.*)
