**UNANIMOUS CONSENT AGREEMENT**

## S.J. RES. 65

1.—*Ordered*, That on Thursday, November 15, 2018, upon the conclusion of Morning Business, the Senator from Kentucky (Mr. Paul), or his designee, be recognized to make a motion to discharge S.J. Res. 65, a joint resolution relating to the disapproval of the proposed export to the Government of the Kingdom of Bahrain of certain defense articles and services; provided, that the time until 12:15 be equally divided between the proponents and opponents; provided further, that upon the use or yielding back of that time, the Senate vote in relation to the motion to discharge; further, that if the motion to discharge is agreed to, S.J. Res. 65 be considered under the expedited procedures under the Arms Export Control Act. (*Nov. 13, 14, 2018.*)
