**UNANIMOUS CONSENT AGREEMENT**

H.R. 5305 (ORDER NO. 137)

*Ordered*, That on Thursday, September 30, 2021, upon the conclusion of Morning Business, the Senate proceed to the consideration of H.R. 5305, an Act making continuing appropriations for the fiscal year ending September 30, 2022, and for providing emergency assistance, and for other purposes; provided, that the Senator from Vermont (Mr. Leahy), or his designee, be recognized to offer substitute Amdt. No. 3830, and that the amendment be reported by number; provided further, that the only first degree amendments in order be the following: Cotton Amdt. No. 3833 (Afghanistan refugees), Marshall Amdt. No. 3831 (Vaccine mandate), and Braun Amdt. No. 3832 (No Budget No Pay); further, that at 10:30 a.m., the Senate vote in relation to the first degree amendments in the order listed, with no second degree amendments in order; provided further, that upon disposition of the first degree amendments, the Senate vote on the substitute, as amended, if amended; further, that the bill be considered read a third time, and the Senate vote on passage of the bill, as amended, if amended; further, that 60 affirmative votes be required for adoption of the Braun and Marshall amendments and passage of the bill; provided further, that there be 2 minutes of debate equally divided prior to each vote; further, that this occur all without intervening action or debate. (*Sept. 29, 2021.*)
