HOUSE MESSAGE TO ACCOMPANY S. 1301

Ordered, That on Thursday, October 7, 2021, the vote on the motion to invoke cloture on the motion to concur in the House amendment to S. 1301, an Act to provide for the publication by the Secretary of Health and Human Services of physical activity recommendations for Americans, occur at a time to be determined by the Majority Leader, following consultation with the Republican Leader, notwithstanding the provisions of Rule XXII; provided, that the mandatory quorum call under Rule XXII be waived.
