UNANIMOUS CONSENT AGREEMENTS

H.R. 3076 (ORDER NO. 266)

1.—*Ordered*, That on Tuesday, March 1, 2022, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 3076, an Act to provide stability to and enhance the services of the United States Postal Service, and for other purposes. (*Feb. 28, 2022.*)

HOUSE MESSAGE TO ACCOMPANY H.R. 5746

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment to H.R. 5746, an Act to amend title 51, United States Code, to extend the authority of the National Aeronautics and Space Administration to enter into leases of non-excess property of the Administration, the mandatory quorum call under Rule XXII be waived. (*Jan. 19, 2022.*)

H.R. 4350 (ORDER NO. 144)

(*Nov. 1, 2021.*)

S. 2747 (ORDER NO. 125)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans' access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)
