UNANIMOUS CONSENT AGREEMENTS

H.R. 4373 (ORDER NO. 310)

1.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 4373, an Act making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2022, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Mar. 29, 2022.*)

HOUSE MESSAGE TO ACCOMPANY H.R. 5746

S. 2747 (ORDER NO. 125)
