PENDING BUSINESS

H.R. 7900 (ORDER NO. 467)

An act to authorize appropriations for fiscal year 2023 for military activities of the Department of Defense and for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes. (*Oct. 11, 2022.*)

UNANIMOUS CONSENT AGREEMENTS

H.R. 8404 (ORDER NO. 449)

1.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 8404, an Act to repeal the Defense of Marriage Act and ensure respect for State regulation of marriage, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Nov. 14, 2022.*)

S.J. RES. 63 (ORDER NO. 523)

2.—*Ordered*, That notwithstanding Rule XXII, at a time to be determined by the Majority Leader, following consultation with the Republican Leader, the Senate proceed to the immediate consideration of S.J. Res. 63, a joint resolution relating to a national emergency declared by the President on March 13, 2020; provided, that there be 30 minutes for debate equally divided in the usual form, and that upon the use or yielding back of time, the joint resolution be considered read a third time, and the Senate vote on passage of the joint resolution, with no further intervening action or debate. (*Nov. 14, 2022.*)

H.R. 350 (ORDER NO. 371)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 350, an Act to authorize dedicated domestic terrorism offices within the Department of Homeland Security, the Department of Justice, and the Federal Bureau of Investigation to analyze and monitor domestic terrorist activity and require the Federal Government to take steps to prevent domestic terrorism, the mandatory quorum call under Rule XXII be waived. (*May 24, 2022.*)

H.R. 4373 (ORDER NO. 310)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 4373, an Act making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2022, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Mar. 29, 2022.*)

HOUSE MESSAGE TO ACCOMPANY H.R. 5746

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment to H.R. 5746, an Act to amend title 51, United States Code, to extend the authority of the National Aeronautics and Space Administration to enter into leases of non-excess property of the Administration, the mandatory quorum call under Rule XXII be waived. (*Jan. 19, 2022.*)

H.R. 4350 (ORDER NO. 144)

6.—*Ordered*, That with respect to H.R. 4350, a bill to authorize appropriations for fiscal year 2022 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the cloture motion with respect to H.R. 4350 ripen following the disposition of Amdt. No. 3867, as modified; provided further, that the filing deadline for first degree amendments to Amdt. No. 3867, as modified, and H.R. 4350 be at 3:30 p.m. on Monday, November 29, 2021; further, that with respect to the motions to invoke cloture on Amdt. No. 3867, as modified, and H.R. 4350, the mandatory quorum calls under Rule XXII be waived. (*Nov. 19, 29, 2021.*)

S. 4 (ORDER NO. 143)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4, a bill to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Nov. 1, 2021.*)

S. 2747 (ORDER NO. 125)

8.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans' access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)
