## UNANIMOUS CONSENT AGREEMENTS

## H.R. 8404 (ORDER NO. 449)

1.—*Ordered*, That on Tuesday, November 29, 2022, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 8404, an Act to repeal the Defense of Marriage Act and ensure respect for State regulation of marriage, and for other purposes; provided, that at 3:45 p.m., all post-cloture time be considered expired; provided further, that it be in order for the Senate to consider Amdt. No. 6482, offered by the Senator from Utah (Mr. Lee), Amdt. No. 6496, offered by the Senator from Oklahoma (Mr. Lankford), and Amdt. No. 6493, offered by the Senator from Florida (Mr. Rubio); provided, that if Amdt. No. 6482, 6496, or 6493 are offered, the Senate vote in relation to the amendments in the order listed, with 60 affirmative votes required for the adoption of Amdt. No. 6482; provided further, that there be two minutes for debate, equally divided, prior to each vote.

*Ordered further*, that any remaining amendments, except Amdt. No. 6487, be withdrawn; provided, that Amdt. No. 6487, as amended, if amended, be agreed to; provided further, that the cloture motion with respect to H.R. 8404 be withdrawn, that the bill be considered read a third time, and the Senate vote on passage of the bill, as amended, with 60 affirmative votes required for passage, without further intervening action or debate. (*Nov. 28, 2022.*)

## H.R. 350 (ORDER NO. 371)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 350, an Act to authorize dedicated domestic terrorism offices within the Department of Homeland Security, the Department of Justice, and the Federal Bureau of Investigation to analyze and monitor domestic terrorist activity and require the Federal Government to take steps to prevent domestic terrorism, the mandatory quorum call under Rule XXII be waived. (*May 24, 2022.*)

## H.R. 4373 (ORDER NO. 310)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 4373, an Act making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2022, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Mar. 29, 2022.*)

## HOUSE MESSAGE TO ACCOMPANY H.R. 5746

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment to H.R. 5746, an Act to amend title 51, United States Code, to extend the authority of the National Aeronautics and Space Administration to enter into leases of non-excess property of the Administration, the mandatory quorum call under Rule XXII be waived. (*Jan. 19, 2022.*)

## H.R. 4350 (ORDER NO. 144)

5.—*Ordered*, That with respect to H.R. 4350, a bill to authorize appropriations for fiscal year 2022 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the cloture motion with respect to H.R. 4350 ripen following the disposition of Amdt. No. 3867, as modified; provided further, that the filing deadline for first degree amendments to Amdt. No. 3867, as modified, and H.R. 4350 be at 3:30 p.m. on Monday, November 29, 2021; further, that with respect to the motions to invoke cloture on Amdt. No. 3867, as modified, and H.R. 4350, the mandatory quorum calls under Rule XXII be waived. (*Nov. 19, 29, 2021.*)

## S. 4 (ORDER NO. 143)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4, a bill to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Nov. 1, 2021.*)

## S. 2747 (ORDER NO. 125)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans' access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)
