UNANIMOUS CONSENT AGREEMENT

S. RES. 13

1.—*Ordered*, That on Thursday, January 26, 2023, upon the conclusion of Morning Business, the Senate proceed to the immediate consideration of S. Res. 13, a resolution raising awareness and encouraging the prevention of stalking by designating January 2023 as “National Stalking Awareness Month”; provided, that 1:45 p.m., the Senate vote on adoption of the resolution; provided further; that if the resolution is agreed to, the preamble be considered and agreed to, and the motions to reconsider be considered made and laid upon the table, with no intervening action or debate.
