UNANIMOUS CONSENT AGREEMENTS

H.J. RES. 45

1.—*Ordered*, That on Thursday, June 1, 2023, upon the conclusion of Morning Business, the Senate resume consideration of H.J. Res. 45, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Education relating to “Waivers and Modifications of Federal Student Loans”; provided, that at 12:15 p.m., the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution. (*May 31, 2023*).

S.J. RES. 4 (ORDER NO. 3)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023*.)

S. 326 (ORDER NO. 32)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023*.)
