UNANIMOUS CONSENT AGREEMENTS

S.J. RES. 4 (ORDER NO. 3)

1.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
