1.—*Ordered*, That with respect to the motion to invoke cloture on the motion to suspend Rule XVI for the consideration of Amdt. No. 1092, offered by the Senator from New York (Mr. Schumer), to H.R. 4366, an Act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2024, and for other purposes, the mandatory quorum call under Rule XXII be waived.
