UNANIMOUS CONSENT AGREEMENTS

H.R. 3935 (ORDER NO. 211)

1.—*Ordered*, That on Wednesday, September 27, 2023, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 3935, an Act to amend title 49, United States Code, to reauthorize and improve the Federal Aviation Administration and other civil aviation programs, and for other purposes; provided, that all time during adjournment, recess, Morning Business, and Leader remarks count towards the post-cloture debate time on the motion to proceed. (*September 26, 2023.*)

S.J. RES. 9 AND S.J. RES. 24

2.—*Ordered*, That notwithstanding Rule XXII, the veto messages with respect to S.J. Res. 9, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the United States Fish and Wildlife Service relating to “Endangered and Threatened Wildlife and Plants; Lesser Prairie-Chicken; Threatened Status With Section 4(d) Rule for the Northern Distinct Population Segment and Endangered Status for the Southern Distinct Population Segment”, and S.J. Res. 24, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the United States Fish and Wildlife Service relating to “Endangered and Threatened Wildlife and Plants; Endangered Species Status for Northern Long-Eared Bat”, be considered at a time to be determined by the Majority Leader in concurrence with the Republican Leader prior to October 4, 2023; provided, that there be up to 2 hours for debate equally divided between the two leaders or their designees on each joint resolution; provided further, that the Senate then vote on passage of the joint resolutions, the objections of the President to the contrary notwithstanding. (*September 26, 2023.*)

H.R. 4366 (ORDER NO. 198)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to suspend Rule XVI for the consideration of Amdt. No. 1092, offered by the Senator from New York (Mr. Schumer), to H.R. 4366, an Act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2024, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*September 18, 2023.*)

S.J. RES. 4 (ORDER NO. 3)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
