**UNANIMOUS CONSENT AGREEMENTS**

## H.R. 815 (ORDER NO. 30)

1.—*Ordered*, That on Thursday, December 7, 2023, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 815, an Act to amend title 38, United States Code, to make certain improvements relating to the eligibility of veterans to receive reimbursement for emergency treatment furnished through the Veterans Community Care program, and for other purposes; provided, that with respect to the motion to invoke cloture on the motion to proceed, the mandatory quorum call under Rule XXII be waived. (*Dec. 4, 6, 2023.*)

## S.J. RES. 51

2.—*Ordered*, That on Thursday, December 7, 2023, if the Senator from Kentucky (Mr. Paul) makes a motion to discharge the Committee on Foreign Relations from further consideration of S.J. Res. 51, a joint resolution directing the removal of United States Armed Forces from hostilities in Syria that have not been authorized by Congress, the Senate vote on the motion to discharge at 11:30 a.m. (*Dec. 6, 2023.*)

## S.J. RES. 4 (ORDER NO. 3)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

## S. 326 (ORDER NO. 32)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
