UNANIMOUS CONSENT AGREEMENTS

S.J. RES. 62 (ORDER NO. 340)

1.—*Ordered*, That on Thursday, March 21, 2024, upon disposition of the Rodriguez nomination, the Senate resume Legislative Session for the consideration of S.J. Res. 62, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Animal and Plant Health Inspection Service relating to “Importation of Fresh Beef From Paraguay”; provided, that the motion to proceed be agreed to and the Senate immediately vote on passage of the joint resolution. (*March 20, 2024.*)

S.J. RES. 4 (ORDER NO. 3)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
