UNANIMOUS CONSENT AGREEMENTS

H.R. 7888 (ORDER NO. 365)

1.—*Ordered*, That on Friday, April 19, 2024, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 7888, an Act to reform the Foreign Intelligence Surveillance Act of 1978; provided, that all time during adjournment, recess, Morning Business, and Leader remarks count post-cloture on the motion to proceed. (*April 18, 2024.*)

S.J. RES. 4 (ORDER NO. 3)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
