UNANIMOUS CONSENT AGREEMENTS

H.J. RES. 109

1.—*Ordered*, That notwithstanding 5 U.S.C. § 802, on Thursday, May 16, 2024, upon the conclusion of Morning Business, the Senate proceed to the consideration of H.J. Res. 109, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Securities and Exchange Commission relating to “Staff Accounting Bulletin No. 121”, which was received from the House and is at the Desk; provided, that at 11:30 a.m., the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution, with all other provisions under chapter 8 of title 5, United States Code, remaining in effect except the 60 session day clock. (*May 15, 2024*).

S.J. RES. 58

2.—*Ordered*, That notwithstanding Rule XXII and 5 U.S.C. § 802, and at a time to be determined by the Majority Leader in consultation with the Republican Leader, no later than May 24, 2024, if S.J. Res. 58, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Energy relating to “Energy Conservation Program: Energy Conservation Standards for Consumer Furnaces”, is discharged from the Committee on Energy and Natural Resources, it be in order for the Senator from Texas (Mr. Cruz) or his designee to move to proceed to the consideration of S.J. Res. 58; provided, that if the motion to proceed is agreed to, there be 10 hours of debate equally divided between the proponents and opponents of the joint resolution; provided further, that upon the use or yielding back of time, the joint resolution be read a third time and the Senate vote on passage of the joint resolution; further, that all other provisions under chapter 8 of title 5, United States Code, remain in effect except the 60 session day clock. (*May 15, 2024*).

H.R. 7791

3.—*Ordered*, That if the Senate receives a message from the House of Representatives that it has passed H.R. 7791, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, and if the text is identical to S. 4057, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detailed or held hostage abroad, and for other purposes, H.R. 7791 be considered as having been read three times and passed, and the motion to reconsider be considered made and laid upon the table. (*April 30, 2023*.)

S.J. RES. 4 (ORDER NO. 3)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023*.)

S. 326 (ORDER NO. 32)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023*.)
