Nominations—Agreement: A unanimous-consent-time agreement was reached providing that the order with respect to the nomination of Debo P. Adegbile, of New York, to be an Assistant Attorney General, be modified so that following Leader remarks on Wednesday, March 5, 2014, the time until 11:45 a.m. be equally divided between the Chairman and Ranking Member of the Judiciary Committee, or their designees, prior to a vote on the motion to invoke cloture on the nomination, with all other provisions of the previous order remaining in effect; that if cloture is invoked, there be four minutes equally divided between the Chairman and Ranking Member of the Judiciary Committee, or their designees prior to the vote on confirmation of the nomination; that following disposition of the nomination of Debo P. Delgado Hernandez, of Puerto Rico, to be United States District Judge

for the District of Puerto Rico; if cloture is not invoked on the nomination of Debo P. Adegbile, of New York, to be an Assistant Attorney General, Senate vote on the motion to invoke cloture on the nomination of Pedro A. Delgado Hernandez, of Puerto Rico, to be United States District Judge for the District of Puerto Rico; provided further, the remaining cloture motions filed on Thursday, February 27, 2014, not ripen prior to 2:15 p.m., on Wednesday, March 5, 2014.
