Honoring the Legacy of A. Philip Randolph: Committee on the Judiciary was discharged from further consideration of S. Res. 218, honoring the legacy of A. Philip Randolph and saluting his efforts on behalf of the people of the United States to form “a more perfect union”, and the resolution was then agreed to. **Pages S3429–30**

Honoring the Life, Accomplishments, and Legacy of Billy Frank, Jr.: Committee on the Judiciary was discharged from further consideration of S. Res. 463, honoring the life, accomplishments, and legacy of Billy Frank, Jr., and expressing condolences on his passing, and the resolution was then agreed to. **Page S3430**

100th Anniversary of Fishermen’s Terminal: Senate agreed to S. Res. 467, recognizing the 100th Anniversary of Fishermen’s Terminal in the Port of Seattle and celebrating Seattle’s rich maritime heritage and its importance to the United States. **Page S3430**

25th Anniversary of Tiananmen Square: Senate agreed to S. Res. 451, recalling the Government of China’s forcible dispersion of those peaceably assembled in Tiananmen Square 25 years ago, in light of China’s continued abysmal human rights record. **Pages S3430–31**
