#### Measures Passed:

**Keystone XL Pipeline:** By 62 yeas to 36 nays (Vote No. 49), Senate passed S. 1, to approve the Keystone XL Pipeline, after taking action on the following amendments and motions proposed thereto: **Pages S620–45**

#### Adopted:

Murkowski (for Barrasso) Modified Amendment No. 245, to clarify that certain consultation requirements with respect to Indian tribes remain in effect. (A unanimous-consent agreement was reached providing that the requirement of a 60 affirmative vote threshold, be vitiated.) **Pages S621, S624**

#### Rejected:

By 47 yeas to 51 nays (Vote No. 42), Daines Amendment No. 246, to express the sense of Congress that reauthorizing the Land and Water Conservation Fund should be a priority. (Pursuant to the order of Wednesday, January 28, 2015, the amendment having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S621–23**

By 59 yeas to 39 nays (Vote No. 43), Burr Modified Amendment No. 92, to permanently reauthorize the Land and Water Conservation Fund. (Pursuant to the order of Wednesday, January 28, 2015, the

amendment having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S621, S623–24**

By 45 yeas to 53 nays (Vote No. 44), Udall Amendment No. 77, to establish a renewable electricity standard. (Pursuant to the order of Wednesday, January 28, 2015, the amendment having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S621, S624**

By 41 yeas to 56 nays (Vote No. 46), Booker Amendment No. 155, to allow permitting agencies to consider new circumstances and new information. **Pages S621, S635–36**

Boxer Amendment No. 130, to preserve existing permits and the authority of the agencies issuing the permits to modify the permits if necessary. **Pages S621, S636**

By 36 yeas to 62 nays (Vote No. 47), Markey Amendment No. 141, to delay the effective date until the President determines that the pipeline will not have certain negative impacts. **Page S636**

By 44 yeas to 54 nays (Vote No. 48), Markey Amendment No. 178, to ensure that products derived from tar sands are treated as crude oil for purposes of the Federal excise tax on petroleum. **Pages S621, S637**

#### Withdrawn:

Vitter/Cassidy Further Modified Amendment No. 80, to provide for the distribution of revenues from certain areas of the outer Continental Shelf. **Pages S621–22**

Cardin Amendment No. 124, to clarify that treaties with Indian tribes remain in effect. **Pages S621, S624–26**

Murkowski (for Sullivan) Amendment No. 67, to restrict the authority of the Environmental Protection Agency to arm agency personnel. **Pages S621, S626**

Murkowski Amendment No. 98, to express the sense of Congress relating to adaptation projects in the United States Arctic region and rural communities. **Pages S621, S626**

Flake Amendment No. 103, to require the evaluation and consolidation of duplicative green building programs. **Pages S621, S626**

Merkley Amendment No. 174, to express the sense of Congress that the United States should prioritize and fund adaptation projects in communities in the United States while also helping to fund climate change adaptation in developing countries. **Pages S621, S626**

Tillis/Burr Amendment No. 102, to provide for leasing on the outer Continental Shelf and the distribution of certain qualified revenues from such leasing. **Pages S621, S626**

Cantwell (for Peters/Stabenow) Amendment No. 55, to require a study of the potential environmental impact of by-products of the Keystone XL pipeline. **Pages S621, S626**

Cantwell/Boxer Amendment No. 131, to ensure that if the Keystone XL Pipeline is built, it will be built safely and in compliance with United States environmental laws. **Pages S621, S637–45**

By 62 yeas to 35 nays (Vote No. 45), three-fifths of those Senators duly chosen and sworn, having voted in the affirmative, Senate upon reconsideration agreed to the motion to close further debate on the bill. **Page S626**

**National Mentoring Month:** Senate agreed to S. Res. 58, recognizing January 2015 as “National Mentoring Month”. **Page S662**

**Clay Hunt SAV Act—Agreement:** A unanimous-consent-time agreement was reached providing that at 4:30 p.m., on Monday, February 2, 2015, Senate begin consideration of H.R. 203, to direct the Secretary of Veterans Affairs to provide for the conduct of annual evaluations of mental health care and suicide prevention programs of the Department of Veterans Affairs, to require a pilot program on loan repayment for psychiatrists who agree to serve in the Veterans Health Administration of the Department of Veterans Affairs; that the time until 5:30 p.m. be equally divided in the usual form, and that following the use or yielding back of time, Senate vote on passage of the bill, without any intervening action or debate. **Page S633**
