Journal: The House agreed to the Speaker's approval of the Journal by voice vote. **Pages H6939, H6965**

Recess: The House recessed at 9:13 a.m. and reconvened at 10:02 a.m. **Page H6941**

Adapting to changing crude oil market conditions: The House passed H.R. 702, to adapt to changing crude oil market conditions, by a recorded vote of 261 ayes to 159 noes, Roll No. 549. **Pages H6941–65**

Rejected the Huffman motion to recommit the bill to the Committee on Energy and Commerce with instructions to report the same back to the House forthwith with an amendment, by a recorded vote of 179 ayes to 242 noes, Roll No. 548. **Pages H6963–64**

Pursuant to the Rule, an amendment in the nature of a substitute consisting of the text of Rules Committee Print 114–29 shall be considered as an original bill for the purpose of amendment under the five-minute rule, in lieu of the amendment in the nature of a substitute recommended by the Com-

mittee on Energy and Commerce now printed in the bill. **Pages H6951–63**

Agreed to:

Delaney amendment (No. 2 printed in part B of H. Rept. 114–290) that adds an additional finding that the United States has reduced its oil consumption over the past decade, and increasing investment in clean energy technology and energy efficiency will lower energy prices, reduce greenhouse gas emissions and increase national security; **Pages H6953–54**

Huffman amendment (No. 3 printed in part B of H. Rept. 114–290) that requires the Secretary of the Energy to complete a study on the net greenhouse gas emissions that will result from the repeal of the crude oil export ban; **Pages H6954–55**

Lawrence amendment (No. 4 printed in part B of H. Rept. 114–290) that requires a study of the State of national implications of lifting the crude oil export ban with respect to consumers and the economy; **Page H6955**

Cuellar amendment (No. 7 printed in part B of H. Rept. 114–290) that provides the Department of Energy authority to continue developing partnerships in the areas of oil and gas exploration, production, midstream, and refining with minority serving institutions, including Hispanic Serving Institutions and Historically Black Colleges and Universities; would encourage public private partnerships between the Department of Energy and minority serving institutions; **Pages H6957–58**

Jackson Lee amendment (No. 9 printed in part B of H. Rept. 114–290) that requires the lifted ban to be assessed after 10 years and directs the Secretaries of Energy and Commerce to work together to review

the impact of lifting the ban as it relates to promoting U.S. energy and national security and report their findings to Congress; **Pages H6958–59**

Jackson Lee amendment (No. 10 printed in part B of H. Rept. 114–290) that directs the Secretaries of Energy and Commerce to work together and submit a report within 180 days on how lifting the ban on crude oil exports will help create opportunities for veterans and women in the U.S., while promoting energy and national security; **Pages H6959–60**

Messer amendment (No. 5 printed in part B of H. Rept. 114–290) that ensures the Administration is able to ban the export of crude oil to state sponsors of terrorism (by a recorded vote of 414 ayes to 1 no, Roll No. 546); and **Pages H6955–56, H6961–62**

Messer amendment (No. 6 printed in part B of H. Rept. 114–290) that prohibits the export of crude oil, refined petroleum products, and petrochemical products to the Islamic Republic of Iran (by a recorded vote of 419 ayes with none voting “no”, Roll No. 547). **Pages H6956–57, H6962–63**

Rejected:

Amash amendment (No. 1 printed in part B of H. Rept. 114–290) that sought to strike section 6 and its related findings in section 1; remove the provision increasing the authorization of appropriations for the Maritime Security Fleet (by a recorded vote of 109 ayes to 306 noes, Roll No. 545). **Pages H6952–53, H6961**

H. Res. 466, the rule providing for consideration of the bills (H.R. 538) and (H.R. 702) was agreed to yesterday, October 8th.

Permission to file report: Agreed that the Committee on the Budget have until 6 p.m. on Friday, October 16th to file a privileged report to accompany a measure to provide for reconciliation pursuant to Title II of the concurrent resolution on the budget for fiscal year 2016. **Page H6965**

Meeting Hour: Agreed by unanimous consent that when the House adjourns today, it adjourn to meet at 2 p.m. on Tuesday, October 13th, and that the order of the House of January 6, 2015, regarding morning-hour debate not apply on that day. **Page H6967**

Discharge Petition: Representative Fincher presented to the clerk a motion to discharge the Committee on Rules from the consideration of the resolution, H. Res. 450, a resolution providing for consideration of the bill, H.R. 597, to reauthorize the Export-Import Bank of the United States, and for other purposes (Discharge Petition No. 2). **Pages H6972–73**

Quorum Calls—Votes: Five recorded votes developed during the proceedings of today and appear on pages H6961, H6962, H6962–63, H6964, H6964–65. There were no quorum calls.
