S. 2713, to provide for the implementation of a Precision Medicine Initiative, with an amendment in the nature of a substitute;

S. 2745, to amend the Public Health Service Act to promote the inclusion of minorities in clinical research, with an amendment in the nature of a substitute; and

S. 2742, to amend title IV of the Public Health Service Act regarding the national research institutes, with an amendment in the nature of a substitute.

#### INDIAN AFFAIRS LEGISLATION

childhood development, education, including Native language and culture, and related services, for evaluation of those demonstration projects, S. 2468, to require the Secretary of the Interior to carry out a 5-year demonstration program to provide grants to eligible Indian tribes for the construction of tribal schools, S. 2580, to establish the Indian Education Agency to streamline the administration of Indian education, and S. 2711, to expand opportunity for Native American children through additional options in education, after receiving testimony from Lawrence S. Roberts, Acting Assistant Secretary of the Interior for Indian Affairs; Arizona State Senator Carlyle W. Begay, Phoenix; Patricia Whitefoot, National Indian Education Association, Washington, D.C.; and Sandra Boham, Salish Kootenai College, Pablo, Montana.
