### Chamber Action

#### Routine Proceedings, pages S1775–S1840

**Measures Introduced:** Twelve bills and one resolution were introduced, as follows: S. 2758–2769, and S. Res. 416. **Page S1809**

#### Measures Passed:

**Prosecution and Conviction of Mohamed Nasheed:** Senate agreed to S. Res. 392, expressing the sense of the Senate regarding the prosecution and conviction of former President Mohamed Nasheed without due process and urging the Government of the Maldives to take all necessary steps to redress this injustice, to release all political prisoners, and to ensure due process and freedom from political prosecution for all the people of the Maldives. **Page S1795**

#### Measures Considered:

**America's Small Business Tax Relief Act—Agreement:** Senate continued consideration of H.R. 636, to amend the Internal Revenue Code of 1986 to permanently extend increased expensing limitations, taking action on the following amendments proposed thereto: **Pages S1778–94 S1795–S1802**

#### Adopted:

By 85 yeas to 10 nays (Vote No. 41), Thune Modified Amendment No. 3512 (to Amendment No. 3464), to enhance airport security. **Pages S1778, S1785–87, S1793**

By 91 yeas to 5 nays (Vote No. 42), Heinrich Modified Amendment No. 3482 (to Amendment No. 3464), to expand and enhance visible deterrents at major transportation hubs and to increase the resources to protect and secure the United States. **Pages S1779–81, S1787**

Thune (for Wyden/Merkley) Modified Amendment No. 3499 (to amendment No. 3464), to require a review of heads-up guidance system displays. **Page S1801**

Thune (for Collins) Amendment No. 3508 (to Amendment No. 3464), to continue the contract weather observers program through the end of fiscal year 2017 and to require the FAA report to identify the process through which the FAA analyzed the safety hazards associated with the elimination of the contract weather observer program. **Page S1801**

Thune (for Tester) Amendment No. 3505 (to Amendment No. 3464), to direct the Comptroller General of the United States to study the costs of deploying advanced imaging technologies at all commercial airports at which TSA security screening operations procedures are conducted. **Pages S1801–02**

Thune (for Heller) Amendment No. 3495 (to Amendment No. 3464), to improve employment opportunities for veterans by requiring the Administrator of the Federal Aviation Administration to determine whether occupations at the Administration relating to unmanned aircraft systems technology and regulations can be incorporated into the Veterans Employment Program of the Administration. **Page S1785**

Thune (for Casey/Toomey) Modified Amendment No. 3458 (to Amendment No. 3464), to protect passengers in air transportation, pilots, and flight attendants from terrorists and mentally unstable individuals by requiring the installation of secondary barriers to prevent cockpit intrusions. **Page S1785**

#### Rejected:

By 42 yeas to 54 nays (Vote No. 43), Nelson (for Schumer) Amendment No. 3483 (to Amendment No. 3464), to require the Federal Aviation Administration to establish minimum standards for space for passengers on passenger aircraft. **Pages S1786–87, S1789**

#### Pending:

Thune/Nelson Amendment No. 3464, in the nature of a substitute. **Page S1778**

Thune (for Gardner) Amendment No. 3460 (to Amendment No. 3464), to require the FAA Administrator to consider the operational history of a person before authorizing the person to operate certain unmanned aircraft systems. **Page S1778**

Nelson (for Bennet) Amendment No. 3524 (to Amendment No. 3464), to improve air service for families and pregnant women. **Page S1785**

Cantwell Amendment No. 3490 (to Amendment No. 3464), to extend protections against physical assault to air carrier customer service representatives. **Pages S1788–89**

A unanimous-consent agreement was reached providing that at 4 p.m., on Monday, April 11, 2016, Senate resume consideration of the bill. **Page S1840**

**Crenshaw Nomination—Agreement:** A unanimous-consent-time agreement was reached providing that at 5 p.m., on Monday, April 11, 2016, Senate begin consideration of the nomination of Waverly D. Crenshaw, Jr., of Tennessee, to be United States District Judge for the Middle District of Tennessee; that there be 30 minutes for debate only on the nomination, equally divided in the usual form; and that upon the use or yielding back of time, Senate vote on confirmation of the nomination, without intervening action or debate.
