Measures Introduced: Nine bills and twenty-five resolutions were introduced, as follows: S. 3460–3468, S. Res. 590–613, and S. Con. Res. 55.

S. 2763, to provide the victims of Holocaust-era persecution and their heirs a fair opportunity to recover works of art confiscated or misappropriated by the Nazis, with an amendment in the nature of a substitute.

Measures Passed:

Gullah/Geechee Cultural Heritage Corridor Commission: Senate passed H.R. 3004, to amend the Gullah/Geechee Cultural Heritage Act to extend the authorization for the Gullah/Geechee Cultural Heritage Corridor Commission.

Bathrooms Accessible in Every Situation Act: Senate passed H.R. 5147, to amend title 40, United States Code, to require restrooms in public buildings to be equipped with baby changing facilities.

Clarification of Treatment of Electronic Sales of Livestock Act: Senate passed H.R. 5883, to amend the Packers and Stockyards Act, 1921, to clarify the duties relating to services furnished in connection with the buying or selling of livestock in commerce through online, video, or other electronic methods.

Randy D. Doub United States Courthouse: Committee on Environment and Public Works was discharged from further consideration of H.R. 3937, to designate the building utilized as a United States courthouse located at 150 Reade Circle in Greenville, North Carolina, as the “Randy D. Doub United States Courthouse”, and the bill was then passed.

National Gallery of Art 75th Anniversary: Committee on Rules and Administration was discharged from further consideration of S. Res. 527, recognizing the 75th anniversary of the opening of

the National Gallery of Art, and the resolution was then agreed to.

Lights On Afterschool: Committee on Health, Education, Labor, and Pensions was discharged from further consideration of S. Res. 578, supporting Lights On Afterschool, a national celebration of afterschool programs held on October 20, 2016, and the resolution was then agreed to.

National Case Management Week: Senate agreed to S. Res. 591, designating the week of October 9 through October 15, 2016, as “National Case Management Week” to recognize the role of case management in improving health care outcomes for patients.

Sickle Cell Disease Awareness Month: Senate agreed to S. Res. 592, expressing support for the designation of the month of September 2016 as “Sickle Cell Disease Awareness Month” in order to educate communities across the United States about sickle cell disease and the need for research, early detection methods, effective treatments, and preventative care programs with respect to sickle cell disease.

National Falls Prevention Awareness Day: Senate agreed to S. Res. 593, designating September 22, 2016, as “National Falls Prevention Awareness Day” to raise awareness and encourage the prevention of falls among older adults.

National Animal Rescue Day: Senate agreed to S. Res. 594, expressing support for designation of the third Saturday in October 2016 as “National Animal Rescue Day” to create awareness of and educate individuals on the importance of adoption of animals, to create a humane environment for any pet, and to encourage animal adoptions throughout the United States.

Grant Assurances: Senate passed H.R. 5944, to amend title 49, United States Code, with respect to certain grant assurances.

Omnibus Territories Act: Senate passed S. 2360, to improve the administration of certain programs in the insular areas, after agreeing to the committee amendment.

United States Appreciation for Olympians and Paralympians Act: Senate passed H.R. 5946, to amend the Internal Revenue Code of 1986 to exclude from gross income any prizes or awards won in competition in the Olympic Games or the Paralympic Games. **Page S6285**

White Mountain Apache Tribe Water Rights Quantification Act: Senate passed S. 2959, to amend the White Mountain Apache Tribe Water Rights Quantification Act of 2010 to clarify the use of amounts in the WMAT Settlement Fund, after agreeing to the committee amendments. **Page S6285**

Nevada Native Nations Land Act: Senate passed H.R. 2733, to require the Secretary of the Interior to take land into trust for certain Indian tribes. **Page S6285**

Women in Coast Guard Academy 40th Anniversary: Committee on Commerce, Science, and Transportation was discharged from further consideration of S. Res. 579, recognizing the 40th Anniversary of the first class of women admitted to the Coast Guard Academy, and the resolution was then agreed to. **Page S6286**

National Adult Education and Family Literacy Week: Senate agreed to S. Res. 600, designating the week of September 26 through 30, 2016, as “National Adult Education and Family Literacy Week”. **Page S6286**

National Dystonia Awareness Month: Senate agreed to S. Res. 601, designating September 2016 as “National Dystonia Awareness Month” and raising awareness and understanding of the disorder of dystonia. **Page S6286**

Texas A&M College of Veterinary Medicine & Biomedical Sciences: Senate agreed to S. Con. Res. 55, commemorating the 100th anniversary of the 1916 opening of the Texas A&M College of Veterinary Medicine & Biomedical Sciences and the 2016 opening of the new Texas A&M Veterinary & Biomedical Education complex in College Station, Texas. **Page S6286**

Adjournment Resolution: Senate agreed to H. Con. Res. 166, providing for a conditional adjournment of the House of Representatives. **Page S6286**

PROTECT Patrimony Resolution: Senate agreed to H. Con. Authorizing Leadership to Make Appointments—Agreement: A unanimous-consent agreement was reached providing that notwithstanding the upcoming adjournment of the Senate, the President of the Senate, the President pro tempore, and the Majority and Minority Leaders be authorized to make appointments to commissions, committees, boards, conferences, or interparliamentary conferences authorized by law, by concurrent action of the two Houses, or by order of the Senate. **Page S6286**

Signing Authority—Agreement: A unanimous-consent agreement was reached providing that the junior Senator from Louisiana be authorized to sign duly enrolled bills or joint resolutions on Thursday, September 29, 2016, through Monday, November 14, 2016. **Page S6286**
