**Budget Resolution:** By 51 yeas to 49 nays (Vote No. 245), Senate agreed to H. Con. Res. 71, establishing the congressional budget for the United States Government for fiscal year 2018 and setting forth the appropriate budgetary levels for fiscal years 2019 through 2027, after taking action on the following amendments proposed thereto:

#### Adopted:

By 52 yeas to 47 nays (Vote No. 226), Capito Amendment No. 1393 (to Amendment No. 1116), to help provide tax relief to middle-class Americans by reducing deductibility, for Federal tax purposes, of federal deductions, such as the state and local tax deduction which disproportionately favors high-income individuals. **Pages S6602–03**

By a unanimous vote of 98 yeas (Vote No. 229), Enzi (for Flake) Amendment No. 1178 (to Amendment No. 1116), to make the American tax system simpler and fairer. **Pages S6615–16, S6618**

Enzi (for Rubio/Lee) Amendment No. 1205 (to Amendment No. 1116), to establish a deficit-neutral reserve fund relating to tax cuts for working American families. **Pages S6615–16, S6619**

Enzi (for Portman) Amendment No. 1422 (to Amendment No. 1116), to provide for an international tax system that provides or enhances incentives for businesses to invest in America, generate

American jobs, retain American jobs, and return jobs to America. **Pages S6615–16, S6620**

Enzi (for Donnelly) Modified Amendment No. 1234 (to Amendment No. 1116), to establish a deficit-neutral reserve fund relating to eliminating tax breaks for companies that ship jobs to foreign countries. **Pages S6615–16, S6620**

By 58 yeas to 41 nays (Vote No. 239), Enzi (for Udall) Amendment No. 1553 (to Amendment No. 1116), to establish a deficit-neutral reserve fund relating to the provision of full, permanent, and mandatory funding for the payment in lieu of taxes program. **Pages S6625–26**

Enzi (for Fisher/Collins) Amendment No. 1552 (to Amendment No. 1116), to provide tax relief to American workers, families, and job creators in a manner which maintains the progressivity of the tax system by maintaining or raising the share of taxes paid by high income taxpayers. **Pages S6625–26, S6628**

By 52 yeas to 48 nays (Vote No. 244), Enzi Amendment No. 1561 (to Amendment No. 1116), to provide other enforcement provisions related to the House of Representatives. **Pages S6625–26, S6628–29**

Enzi (for Perdue/Whitehouse) Amendment No. 1167 (to Amendment No. 1116), to establish a deficit-neutral reserve fund relating to significantly improving the budget process. **Pages S6625–26, S6629**

Enzi Amendment No. 1116, in the nature of a substitute. **Pages S6593–S6629**

#### Rejected:

By 47 yeas to 52 nays (Vote No. 225), Wyden Amendment No. 1302 (to Amendment No. 1116), to strike the reconciliation instructions relating to tax reform. **Pages S6594–S6602**

By 47 yeas to 51 nays (Vote No. 228), Warner Amendment No. 1138 (to Amendment No. 1116), to strike the Senate pay-as-you-go exemption for tax cut reconciliation legislation and the exception to rules preventing any legislation from increasing the deficit over the short-term. **Pages S6611–12**

By 47 yeas to 51 nays (Vote No. 230), Enzi (for Baldwin) Amendment No. 1139 (to Amendment No. 1116), to prohibit reconciliation legislation that would increase the deficit or reduce a surplus.

**Pages S6615–16, S6618–19**

By 47 yeas to 51 nays (Vote No. 232), Brown Amendment No. 1378 (to Amendment No. 1116), to establish a deficit-neutral reserve fund relating to providing tax benefits to patriot employers that invest in American jobs and provide fair pay and benefits to workers.

**Pages S6620–21**

By 4 yeas to 94 nays (Vote No. 233), Enzi (for Paul) Amendment No. 1296 (to Amendment No. 1116), to modify reconciliation instructions to reduce the deficit.

**Pages S6621–22**

By 48 yeas to 51 nays (Vote No. 235), Enzi (for Kaine) Amendment No. 1249 (to Amendment No. 1116), to modify section 4111 to reinstate and strengthen a prohibition on voting on legislation without a Congressional Budget Office score.

**Pages S6615–16, S6622–23**

By 5 yeas to 95 nays (Vote No. 236), Enzi (for Paul) Amendment No. 1298 (to Amendment No. 1116), to reduce discretionary spending by \$43,000,000,000.

**Pages S6622–24**

By 32 yeas to 67 nays (Vote No. 237), Enzi (for Lee) Amendment No. 1430 (to Amendment No. 1116), to expand the deficit-neutral reserve fund relating to the repeal of provisions of title I of the Patient Protection and Affordable Care Act.

**Pages S6622–25**

By 33 yeas to 66 nays (Vote No. 238), Enzi (for Paul) Amendment No. 1277 (to Amendment No. 1116), to provide for reconciliation instructions to the relevant committees for the purpose of repealing and replacing the Patient Protection and Affordable Care Act.

**Pages S6622–23, S6625**

By 50 yeas to 50 nays (Vote No. 240), Enzi (for Lee) Amendment No. 1428 (to Amendment No. 1116), to modify a deficit neutral reserve fund relating to public land and the environment to address making payments under the payments in lieu of taxes program equivalent to the property tax revenue that would be due to a State or local government if the State or local government owned the land.

**Pages S6625–27**

By 7 yeas to 93 nays (Vote No. 241), Enzi (for Paul) Amendment No. 1404 (to Amendment No. 1116), to ensure that all Americans receive a tax cut, keeping more of their hard earned money, and enjoy the benefit of tax reform.

**Pages S6625–27**

By 49 yeas to 51 nays (Vote No. 242), Enzi (for Lee) Amendment No. 1429 (to Amendment No. 1116), to establish a spending-neutral reserve fund relating to prohibiting Federal regulation of entirely

intrastate species under the Endangered Species Act of 1973.

**Pages S6625–28**

By 48 yeas to 52 nays (Vote No. 243), Enzi (for Cantwell) Amendment No. 1301 (to Amendment No. 1116), to strike the reconciliation instructions for the Committee on Energy and Natural Resources of the Senate to prevent oil and gas development within the Arctic National Wildlife Refuge.

**Pages S6625–26, S6628**

During consideration of this measure today, Senate also took the following action:

By 47 yeas to 52 nays (Vote No. 227), three-fifths of those Senators duly chosen and sworn not having voted in the affirmative, Senate rejected the motion to waive section 305(b)(2) of the Congressional Budget Act of 1974 with respect to consideration of Cantwell/Van Hollen Amendment No. 1141 (to Amendment No. 1116), to create a point of order against legislation that would raise taxes on middle class families by double-taxing income already taxed at the state or local level. Subsequently, the point of order that the amendment violates section 305(b)(2) of the Congressional Budget Act of 1974 was sustained, and the amendment thus fell.

**Pages S6603–04**

By 47 yeas to 51 nays (Vote No. 231), three-fifths of those Senators duly chosen and sworn not having voted in the affirmative, Senate rejected the motion to waive section 305(b)(2) of the Congressional Budget Act of 1974 with respect to consideration of Enzi (for Heitkamp) Amendment No. 1228 (to Amendment No. 1116), to create a point of order against legislation that would increase taxes on taxpayers whose annual income is below \$250,000. Subsequently, the point of order that the amendment violates section 305(b)(2) of the Congressional Budget Act of 1974 was sustained, and the amendment thus fell.

**Pages S6615–16, S6619–20**

By 47 yeas to 52 nays (Vote No. 234), three-fifths of those Senators duly chosen and sworn not having voted in the affirmative, Senate rejected the motion to waive section 305(b)(2) of the Congressional Budget Act of 1974 with respect to consideration of Enzi (for Cardin/Blumenthal) Amendment No. 1375 (to Amendment No. 1116), to create a point of order against legislation that includes deficit-financed tax cuts. Subsequently, the point of order that the amendment violates section 305(b)(2) of the Congressional Budget Act of 1974 was sustained, and the amendment thus fell.
