**National Defense Authorization Act:** By 85 yeas to 10 nays (Vote No. 128), Senate passed H.R. 5515, to authorize appropriations for fiscal year 2019 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, after taking action on the following motion proposed thereto:

By 81 yeas to 14 nays (Vote No. 127), three-fifths of those Senators duly chosen and sworn, having voted in the affirmative, Senate agreed to the motion to waive section 4106(b)(1) of H. Con. Res. 71, es-

tablishing the congressional budget for the United States Government for fiscal year 2018 and setting forth the appropriate budgetary levels for fiscal years 2019 through 2027, with respect to Inhofe/McCain Modified Amendment No. 2282, in the nature of a substitute, to the bill. Subsequently, the point of order that the pending measure was in violation of section 4106 of H. Con. Res. 71, was not sustained, and thus the point of order fell. **Page S3972**
