**Measures Introduced:** Four bills and three resolutions were introduced, as follows: S. 3296–3299, and S. Res. 597–599. **Page S5455**

#### Measures Reported:

H.R. 4567, to require a Department of Homeland Security overseas personnel enhancement plan. (S. Rept. No. 115–308)

H.R. 497, To direct the Secretary of the Interior to convey certain Federal lands in San Bernardino County, California, to the San Bernardino Valley Water Conservation District, and to accept in return certain non-Federal lands.

H.R. 2582, to authorize the State of Utah to select certain lands that are available for disposal under the Pony Express Resource Management Plan to be used for the support and benefit of State institutions.

H.R. 2768, to designate certain mountain peaks in the State of Colorado as “Fowler Peak” and “Boskoff Peak”.

H.R. 2897, to authorize the Mayor of the District of Columbia and the Director of the National Park Service to enter into cooperative management agreements for the operation, maintenance, and management of units of the National Park System in the District of Columbia, with an amendment in the nature of a substitute.

H.R. 4609, to provide for the conveyance of a Forest Service site in Dolores County, Colorado, to be used for a fire station.

S. Res. 501, recognizing threats to freedom of the press and expression around the world and reaffirming freedom of the press as a priority in efforts of the Government of the United States to promote democracy and good governance, and with an amended preamble.

S. Res. 541, expressing the sense of the Senate that any United States-Saudi Arabia civilian nuclear cooperation agreement must prohibit the Kingdom of Saudi Arabia from enriching uranium or separating plutonium on its own territory, in keeping with the strongest possible nonproliferation “gold

standard”, with an amendment in the nature of a substitute and with an amended preamble.

S. Res. 571, condemning the ongoing illegal occupation of Crimea by the Russian Federation, with an amendment in the nature of a substitute and with an amended preamble.

S. 436, to authorize the Secretary of the Interior to retire coal preference right lease applications for which the Secretary has made an affirmative commercial quantities determination, to substitute certain land selections of the Navajo Nation, to designate certain wilderness areas, with amendments.

S. 440, to establish a procedure for the conveyance of certain Federal property around the Dickinson Reservoir in the State of North Dakota, with an amendment in the nature of a substitute.

S. 930, to require the Administrator of the Western Area Power Administration to establish a pilot project to provide increased transparency for customers, with an amendment in the nature of a substitute.

S. 1023, to reauthorize the Tropical Forest Conservation Act of 1998 through fiscal year 2021, with an amendment in the nature of a substitute.

S. 1030, to require the Federal Energy Regulatory Commission to submit to Congress a report on certain hydropower projects, with an amendment in the nature of a substitute.

S. 1142, to extend the deadline for commencement of construction of certain hydroelectric projects, with an amendment in the nature of a substitute.

S. 2074, to establish a procedure for the conveyance of certain Federal property around the Jamestown Reservoir in the State of North Dakota, with an amendment in the nature of a substitute.

S. 2102, to clarify the boundary of Acadia National Park, with an amendment in the nature of a substitute. **Pages S5454–55**

tion to invoke cloture on Shelby Amendment No. 3399, to H.R. 6147, making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2019. **Page S5462**

A unanimous-consent agreement was reached providing for further consideration of the nomination, post-cloture, at approximately 10 a.m., on Tuesday, July 31, 2018. **Page S5462**
