Suspensions: The House agreed to suspend the rules and pass the following measures:

Veterans' Compensation Cost-of-Living Adjustment Act of 2020: H.R. 6168, to increase, effective as of December 1, 2020, the rates of compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for the survivors of certain disabled veterans; **Pages H2327–28**

Major Medical Facility Authorization Act of 2020: S. 3414, to authorize major medical facility projects for the Department of Veterans Affairs for fiscal year 2020; **Pages H2328–29**

Amending title 38, United States Code, to modify the limitation on pay for certain high-level employees and officers of the Department of Veterans Affairs: S. 3084, amended, to amend title 38, United States Code, to modify the limitation on pay for certain high-level employees and officers of the Department of Veterans Affairs; and **Pages H2329–30**

Paycheck Protection Program Flexibility Act of 2020: H.R. 7010, amended, to amend the Small Business Act and the CARES Act to modify certain provisions related to the forgiveness of loans under the paycheck protection program, to allow recipients of loan forgiveness under the paycheck protection program to defer payroll taxes, by a $\frac{2}{3}$ yeas-and-nays vote of 417 yeas to 1 nay, Roll No. 114. **Pages H2332–38, H2339–40**

Suspensions: The House failed to agree to suspend the rules and pass the following measure:

Small Business Transparency and Reporting for the Underbanked and Taxpayers at Home Act: H.R. 6782, amended, to require the Administrator of the Small Business Administration to submit a report on recipients of assistance under the paycheck protection program and the economic injury disaster loan program, by a $\frac{2}{3}$ yeas-and-nays vote of 269 yeas to 147 nays, Roll No. 113. **Pages H2330–32, H2338–39**

Moment of Silence: The House observed a moment of silence in remembrance of the over 100,000 Americans who have passed away from the COVID-19 virus. **Page H2340**

USA FREEDOM Reauthorization Act of 2020: The House agreed to the Nadler motion to disagree to the Senate amendments and request a conference with the Senate on H.R. 6172, to require the Administrator of the Small Business Administration to submit a report on recipients of assistance under the paycheck protection program and the economic injury disaster loan program, by a yeas-and-nays vote of 284 yeas to 122 nays, Roll No. 115. **Pages H2340–46**
