McConnell Amendment No. 1632 (to Amendment No. 1631), of a perfecting nature, fell when McConnell Amendment No. 1631 (to (the instructions) Amendment No. 1630) fell. **Page S2956**

A unanimous-consent agreement was reached providing that the post-cloture time with respect to McConnell (for Gardner) Amendment No. 1617, expire at 5:30 p.m., on Monday, June 15, 2020; and that Senator Enzi or his designee be recognized prior to the vote on adoption of the amendment to raise a budget point of order; and that following the raising of that point of order, Senator Gardner or his designee be recognized to make a motion to waive the point of order. **Page S2957**

A unanimous-consent agreement was reached providing that Senate resume consideration of the bill at approximately 3 p.m., on Monday, June 15, 2020. **Page S2957**
