Uyghur Human Rights Policy Act: Senate continued consideration of the amendment of the House of Representatives to S. 178, to condemn gross human rights violations of ethnic Turkic Muslims in Xinjiang, and calling for an end to arbitrary detention, torture, and harassment of these communities inside and outside China, taking action on the following motions and amendments proposed thereto: **Page S6318**

A motion was entered to close further debate on the nomination, and, in accordance with the provisions of Rule XXII of the Standing Rules of the Senate, a vote on cloture will occur on Thursday, October 22, 2020. **Pages S6319–20**

By 52 yeas to 43 nays (Vote No. 205), Senate agreed to the motion to proceed to Executive Session to consider the nomination. **Page S6319**

Motion to Adjourn: By 52 yeas to 43 nays (Vote No. 206), Senate agreed to the motion to table Schumer motion to appeal the ruling of the Chair that the Schumer motion to adjourn the Senate was not in order. Subsequently, Schumer motion to appeal the ruling of the Chair was rejected. **Page S6320**
